1 WHEREAS, on August 23, 2017, plaintiff withdrew its designation of Mr. Stern as a
2 testifying expert and requested that the City agree to a trial continuance and extension of the
3 expert discovery deadlines to permit it to retain a non-conflicted expert; and

4 WHEREAS, the City agreed to plaintiff's requests, but only on the condition that the parties
5 agree to, and the Court endorse, the provisions concerning discovery set forth in this stipulation.

6 The parties therefore stipulate that the Court should order as follows:

7 1. Trial in this matter shall be continued from September 11, 2017 to ~~November 8, 2017,~~ ^{January 10, 2018}
8 if that date is available on the Court's calendar.

9 2. The pretrial conference shall be continued from ~~August 30, 2017~~ to
10 ~~Jan 9th~~ ^{Jan 9th}, 2018, at ~~10~~ ² pm.

11 3. If the above trial date is not available, the Court will notify the parties regarding
12 available dates, and the parties will select an alternate trial date.

13 4. Plaintiff will serve an amended expert designation on or before September ~~22,~~ ²⁹ 2017.

14 5. The parties will complete depositions of designated experts by October ~~20,~~ ²⁷ 2017.



15 6. Notwithstanding anything in the foregoing paragraph 5, defendant may make a


